### INTRODUCTION

This website is owned and operated by Park Retail Ltd (registered in England with company number 402152) ("**Park Retail**").

Park Retail is a subsidiary of Appreciate Group plc. (registered in England with company number 1711939) ("**Appreciate Group**").

Both Park Retail and Appreciate Group have their registered office at Valley Road, Birkenhead, Merseyside, CH41 7ED and throughout this cookie policy these companies shall together be referred to as "**our/us/we**".

This cookie policy together with our website terms and conditions and privacy policy (both of which can be accessed by following the links at the footer of this website) set out the basis on which you visit and use our website and place orders.

### WHAT ARE COOKIES?

Cookies are small text files placed on your computer by our website/mobile app, we use cookies for a number of purposes including to:

- keep track of what you have in your basket;
- remember you when you return to one of our sites; or
- help us understand if our marketing is working or not.

Certain cookies are necessary in order for you to use our websites, such as the 'My Account' section (once you have logged in). These are called 'Session Cookies' they are used each time you visit our site and expire when you leave.

Other cookies we use remain on your computer and are sent to keep track of your browsing patterns and build up a profile. These are called 'Tracking Cookies' and enable us to recognise repeat visitors to our site, the pages that were viewed and the paths taken through our site.

By monitoring this information, we are able to make improvements to our site.
